The 'Prince Charles' was drove ashore at Ostend by two English privateers, and thought to be destroyed; but being afterwards repaired, she sailed; and, being an excellent sailor, escaped the vigilance and pursuit of six or seven English ships that were cruising off that port to watch her. On the 24th of March, she was descried by four English ships at anchor off Troup Head. On sight of them she bore away. Thereupon the (HMS) 'Sheerness'. Cant. O'Brian.
